### Follow-up of the

### MLE on Alignment and Interoperability of National Research Programmes

Launched in July 2016 under the H2020 PSF, the Mutual Learning Exercise (MLE) brought together representatives from 11 EU MS/AC (Austria, Denmark, Estonia, France, Norway, Portugal, Romania, Slovenia, Sweden, Turkey and Germany) to discuss ways to foster better alignment and interoperability of national research programmes. The MLE focussed on those aspects related to national preconditions for better participation in the joint programming process (JPP).

The MLE concluded in the second half of 2017 with the publication of its [Final Report](#). Throughout the course of the MLE, good practices were identified and transferable lessons proposed. Participating countries to the MLE also reflected on concrete follow-up activities to be implemented in their own countries to improve their alignment with the Joint Programming Initiatives. To take stock on the progress achieved and test the feasibility of some of the proposed actions, it was agreed that a follow-up meeting would be organised after one year:

*“We should have a reunion in 12 months after the end for an update on progress. It is too easy to lose momentum”*

On 6 March 2018, GPC agreed that the MLE follow-up will take place at the next GPC meeting on 5 June 2018.
